Application Deadline: February 21, 2021

CrossState Leadership School Scholarship was established in 1972 to perpetuate the memory of all past Association Board of Directors and is awarded annually to deserving credit union professionals of a member credit union who wish to attend the CrossState Leadership School. Recipients receive tuition and hotel expenses for four nights. Due to the cancellation of the 2020 CrossState Leadership School, 2020 scholarships won will be honored in 2021. It will not be necessary to reapply. CrossState Credit Union Association will award two scholarships in 2021 for the CrossState Leadership School.

Application Guidelines:

- All sections must be completed and typewritten. Points are assigned to each category during the judging process.
- All applications must be signed by the applicant and their supervisor.
- You may apply for more than one professional development scholarship; however, separate essays must be submitted.
- The decisions of the Association Awards Committee will be final.
- Employees of the CrossState Credit Union Association and its affiliates, members of their immediate families, current members of the Board of Directors and Awards Committee, and members of their immediate families are ineligible for this award.
