### Create Hope for the Future: Making an Impact

This story says it all about credit unions creating hope when educating young people about financial tools.

At a Financial Reality Fair a few years ago, First Choice FCU CEO and Foundation Board member Michael Vatter, talked to a student who didn't want to go to college and didn't have any career ideas. Michael suggested he consider a trade school or explore a junior college. He is now a successful electrician at age 23 and holds two credit union business loans due to his growing business.

He thanked Michael for his advice and for encouraging him. Michael made a huge impact on his career choice. His mom said he was always a "good boy, but he lacked focus and direction." Now, he is thriving! Michael says, "He is doing great work in our community. He had it in him all the time, I just ended up being a person that he connected with and we would occasionally email. He put the work in, made good decisions, and is dedicated to his career. I was just a sounding board to him; he is well on his way to becoming a pillar of the Community."

For 2023, our theme was *CREATE HOPE FOR THE FUTURE*. We started pursuing this message by holding a strategic planning session with the Foundation Board of Directors and creating a vision statement, mission, and strategic priorities. This process was inspiring and drove our work for 2023!

# FOUNDATION GRANTS TO THE CROSSSTATE NETWORK

Create Hope for the Future: Building Capacity is Key



- Professional Development Grants:

  BSA Trainings.
- Small CU Assistance Grants: Equipment upgrade, debit card program for displaced refugees, computer software upgrade, and marketing initiatives for member expansions.

In 2023, the Foundation funded over \$120,000 in grants, which included: professional development grants for chapters holding educational workshops and credit unions needing BSA Trainings; small credit union assistance grants supporting capacity for equipment, technology, and member recruitment; and financial literacy grants focusing on financial literacy apps partnerships and school programs. Disaster relief funding assisted fellow credit unions in Turkey, Reading, PA, and Hawaii.

In August 2023, the Foundation received a special donation from Vizo Financial to distribute funds for a one-time grant, Vizo Financial Empowerment Grants, for our network. The Foundation distributed \$30,000 in 2023 to credit unions for a financial education app, outreach programs, a Financial Reality Fair Kit, employees taking FiCEP, and working with Junior Achievement.

With review and approval by the Foundation's Grant and Awards Committee and the Board of Directors, grants were given throughout the year, and we are grateful for the time and expertise of our committee members. The committee also annually reviews the guidelines to ensure that all credit unions have easy access to the grant process.

# KATHLEEN FEY EXECUTIVE LEADERSHIP PROGRAM

Create Hope for the Future: Inspiring Leadership is Key

In 2023, two more fellows completed the 6-year program. The program started in 2016 and currently has 5 fellows and 2 alumni. In 2023, over \$28,000 was funded for these fellows to attend trainings. The Foundation funds registration, travel, and lodging for the following training: two years of CrossState Leadership School, one year of the National Credit Union Foundation's DE Training, and three years of CUNA Management School. Each year, two active Emerging Leader members are selected as Credit Union Fellows to participate in the program.

A unique part of the program is for each fellow to have mentors throughout their six years. We are grateful for the leadership of our mentors supporting the fellows as they navigate this program and their careers. In 2023, our mentors were Traci Donahue, Terri Lannon, Vince Market, Pam Mohn, Deb Mozal, John Murga, and Michael Vatter.

## ENHANCED FINANCIAL COUNSELING CERTIFICATION PROGRAM

Create Hope for the Future: Member Financial Wellness is Key

Since 2018, we have had 209 credit union professionals participate in this program. In 2023, we had 71 credit union professionals participate in this program to receive their certification for credit union financial counselor (CCUFC). Thanks to increased marketing of the program and the generous sponsorship from Vizo Financial, this was a banner year of having 20-40 registrants.

The Enhanced FiCEP program provides the resources to learn critical information in financial counseling and to be able to pass CUNA's certification program with high scores. The Enhanced program is reasonably priced due to the support of the Foundation. The program includes, 8-week training taken at your own pace, the FiCEP textbook, a virtual exam review, and the virtual proctored exam.

### **CU KIND DAY**

Create Hope for the Future: People Helping People is Key

In October 2023, over 60 credit unions in New Jersey and Pennsylvania joined together and used their creativity to donate, volunteer, and educate their members and communities by demonstrating the People Helping People philosophy. Credit unions donated food to animal shelters and zoos, packed boxes at food pantries, volunteered at children's hospitals, made sandwiches for their local fire departments. This list goes on – they made a difference in their communities and showed the credit union compassion!

### FINANCIAL REALITY FAIRS

Create Hope for the Future: Financial Education is Key

Last year, schools returned to being able to invite credit unions to run Financial Reality Fairs for their students. We had over 30 Fairs, reaching 6,000 students with the help of over 540 volunteers. Financial Reality Fairs are a hands-on budgeting experience for students to gain practical knowledge about budgeting and personal finance in the "real world." Fairs are held in high schools, technical schools, and colleges.

In 2023, a Financial Reality Fair User Group was created to bring together folks who run the fairs and those who want to run the fairs. The User Group of over 50 individuals meets regularly to discuss best practices, what is the best information needed for recruiting schools and educating students, and how to reach more students across our network in New Jersey and Pennsylvania. In the coming year, the User Group will be addressing bilingual materials and how to work more collaboratively with each other.

## REACHING BEYOND SCHOOLS: Partnerships to Reach Adults in Need

The Foundation, working in conjunction with the Pennsylvania Department of Corrections and the Pennsylvania Department Banking & Securities, held a Financial Reality Fair on October 20 at Pennsylvania CareerLink in Harrisburg, PA. The event welcomed over 70 individuals reentering society to learn how to build a budget and apply financial concepts to develop a strong financial foundation. Forty-three volunteers from 10 New Jersey and Pennsylvania credit unions showed their support of financial education at the event. The Foundation hopes to hold Reality Fairs for people leaving the prison system in other parts of New Jersey and Pennsylvania.

The challenge was to encourage members to make smarter, more calculated financial decisions, positioning them for a healthier financial future.



#### White Rose Credit Union: Customizable Financial Education Offerings for Local Schools: A

Financial Education Offerings Packet was created to build a customizable program for the need of each classroom.

An additional award was given for their special collaborative spirit: **The Greater Reading Financial Reality Fair Committee.** Ten credit unions in the greater Reading area join forces to hold Financial Reality Fairs in their communities. The Grants and Awards Committee decided to make this a new category for the Financial Literacy awards to highlight the true essence of credit unions, collaboration.

All these winners work closely with schools, community organizations, and their members to reach community members in need of financial education. For more information about these programs, you can go to the Foundation website.

## PROMOTING FINANCIAL LITERACY LEADERS:

The presentations included credit union experts discussing one on one financial counseling, school classroom sessions, financial reality fairs and financial education websites and social media. These programs were very well attended, and credit unions received useful information and helpful connections to implement their own financial education programs.
